PURPOSE STATEMENT

The PLSLSC Club Captain is responsible for overseeing the delivery of PLSLSC's lifesaving services and emergency response capabilities.

ROLE & RESPONSIBILITIES

The Club Captain is responsible for:

- As a member of PLSLSC's Board, responsible for oversight of risk, finance, strategy and culture within the Club.
- Chairing the Life Saving Services Executive and managing the Club Vice Captain (Life Saving Services), Club Vice Captain (Gear & Equipment), LERT Captain and other responsible officers.
- Communicating regularly to Active Members and being responsible, generally for all Active Members to ensure compliance with PLSLSC's policies and minimum standards.
- Managing adherence to requirements within Life Saving Victoria and Surf Life Saving Australia's Policies and Standard Operating Procedures.
- Ensuring the efficiency of patrols; including maintaining a record of attendance at and of all lifesaving work performed by members of the Club. Keep a record of members performances at patrol duties
- Ensuring compliance with OHS requirements at all times relevant to the Officer's responsibilities.
- Ensuring appropriate risk assessments are conducted before activities relevant to the officer's responsibilities
- Working with Director Training and Assessment to address training requirements and deficiencies and ensure members requalify their awards in a timely manner.
- Developing initiatives to develop and expand PLSLSC's emergency response capabilities.
- Represent PLSLSC appropriately at local, regional, state and national levels (including LSV's Life Saving
 Operations Council and the Borough of Queenscliffe's Municipal Emergency Management Plan Committee).
- Ensuring all Active Members hold the requisite awards (including annual re-qualifications) when on Patrol
- Overseeing the Life Saving Services Executive in:
 - Administering and organising patrols (rosters, experience/qualification spread)
 - Communicating key development, operational objectives and providing support to Patrol Captains
 - Ensuring all Club patrol/rescue equipment serviceable in accordance with SLSA and LSV requirements
 - Coordinating the pre-season preparation phase (equipment/uniforms, rostering, communication etc)
 - Communicating with patrol defaulters to maintain efficiency of patrols
 - Delivering the Club's programs to ensure efficiency and compliance, including through the Patrol Audit.
